CONGESTION TAX SCHEME ISSUES REMAIN UNADDRESSED 11th Truth: Too Many Questions; So Few Answers

Keep NYC Congestion Tax Free announces the eleventh *Truth About* the City congestion tax plan to assist the public, their elected officials and the members of the commission as they move to a more deliberative stage: Nearly nine months later, New Yorkers still look for basic answers when it comes to the city's congestion tax scheme (and its recent variants):

- ? Where are the iron-clad legal guarantees of a net increase in mass transit funding? Why are there no "lockbox" assurances for funding dedicated to mass transit improvements? Will this tax be just like the Lottery for every Lottery dollar in, government cuts out a dollar it used to allocate?
- ? Why does the City plan rely on privatization to construct and operate the congestion tax infrastructure, ignore prevailing wage and waive "Buy America" provisions for procurement.

One way to answer questions starts with jettisoning the congestion tax plans that raise so many red flags. Instead, look at traffic mitigation measures that makes sense for New York such as the <u>measures</u> proposed by Keep NYC Congestion Tax Free with its one-half billion or more in incidental revenues and the <u>revenue</u> measures proposed by its coalition partner, the Queens Civic Congress, which raises nearly 1.8 billion (\$1,774,000,000, based on the commission's analysis).
